

Pharmaceuticals in Water

On March 6, 2006, CIELAP released a report entitled 'There Is No "Away" - Pharmaceuticals, Personal Care Products, and Endocrine-Disrupting Substances: Emerging Contaminants Detected in Water'. The report was authored by Susan Holtz, Senior Policy Analyst at CIELAP.

This report provides an overview of the issue of emerging contaminants (including pharmaceuticals, personal care products and endocrine-disrupting substances) that are now being detected in low concentrations nearly everywhere in surface and groundwater, and also in treated drinking water.



The report's key recommendations include:

- 1. Supporting or developing province-wide product stewardship programs for return of unused drugs.
- 2. Significantly increasing research efforts and funding for science related to these issues, including surveillance and monitoring, environmental risks, ecological science, and human and wildlife health.
- Increasing public education through an environmental labeling program and/or identification of products free of both suspected endocrine disruptors and antimicrobial substances linked to antibiotic resistance. As more information is acquired, problematic ingredients should be banned.
- 4. Supporting or developing municipal by-laws banning pharmaceuticals and other chemical discards in sewers and restricting pesticide use; ensuring enforcement capability and action.

Ontario's Greenbelt Act & Places to Grow Act – a CIELAP Knowledge Cluster

CIELAP is looking to undertake an analysis of gaps and inconsistencies between Ontario's new *Greenbelt Act* and *Places to Grow Act*, as well as other planning legislation and policies including the *Niagara Escarpment Planning and Development Act*, the *Oak Ridges Moraine Conservation Act*, the *Planning Act* and the 2005 Provincial Policy Statement. This analysis will include clarifying which plans and policies take precedence over others, and what this means for environmental protection.

CIELAP is holding a knowledge cluster meeting on this topic on Thursday March 30th from 5:30 – 7:00 at the CIELAP office, 130 Spadina Ave, Toronto. **Maureen Carter-Whitney**, CIELAP Research Director, will lead this session and will invite participants to give their input on and offer their assistance with this initiative.

Also consider attending our future meetings, including **Youth and Community Engagement** on April 27 2006 from 5:30 – 7:00 and **Policy Gaps in the Proposed Ontario Biodiversity Strategy**, to be held on May 25 2006 from 5:30 – 7:00.

If you haven't yet heard about our **Knowledge Clusters**, they are groups of people, similar to advisory groups, who have a specific interest and expertise in one of the 5 <u>core areas</u> related to CIELAP's work. Those who make up the KCs may be called upon to assist CIELAP's research at any stage of a project, including **brainstorming** ideas for new research and

funding sources, **reviewing** or **helping with research** for a report or funding proposal, **referring** us to your contacts or other information sources, or taking part in any other stage of the research process.

The <u>monthly meetings</u> will give KCs opportunities to meet and discuss future directions for addressing pressing environmental issues. When you come to a KC meeting you'll not only hear about an issue but you'll also be invited to **give your input**, **discuss** how CIELAP can address this issue, and you can choose to **offer your help and expertise**.
