## WHAT'S NEW

This October, Anne and Jennifer traveled to Ottawa to meet with federal departments regarding the findings of CIELAP's paper "Sustainable Development in Canada: A New Federal Plan." CIELAP's newest paper was funded by the TD Friends of the Environment Foundation and the J W McConnell Family Foundation, and was written under the direction of Karen Clark. The paper is a critical examination of the rhetoric surrounding sustainability, including the struggle to define the term, the use of indicators, and the role of innovation in moving towards a more sustainable society. Written in easy-to-understand language, the discussion around sustainability helps to "blow the dust" off of some of the terms and definitions surrounding sustainable development.

The report specifically examines Canada's approach to sustainable development. At the World Summit on the Environment and Sustainable Development in 1992, Canada committed to preparing a national strategy for sustainable development. Canada's approach has been to assign this task to the different departments and ministries, requiring them to produce sustainable development strategies every three years. CIELAP argues that this has resulted in an uncoordinated, ineffective approach to sustainable development in this country that cannot be called a federal strategy, let alone a national strategy.

"Sustainable Development in Canada: A New Federal Plan" suggests a new approach for the federal government. The proposed "Four-Step Plan" involves defining an SD objective using all actors in sustainability (government, NGOs, industry), setting short terms goals to reach the objective, measuring progress using indicators, and testing for sustainability to see if the objective has been met.

In Ottawa, CIELAP met with civil servants responsible for writing sustainable development strategies including Environment, Natural Resources, Health, and Finance. Many individuals supported CIELAP's opinions, recognizing the lack of a cohesive federal or national strategy themselves. CIELAP was invited to return to Ottawa to speak with the Inter-Departmental Network of Sustainable Development Strategies, as well as to the NDP caucus.

Anthony Watanabe from the Strategy Institute traveled to Ottawa as well to speak about the upcoming "Partnering for Sustainability" conference scheduled for April 8-9 in Toronto. The conference is a unique partnership between a for-profit conference developer and an NGO. The

purpose of the conference is to highlight successful sustainable partnership initiatives between not-for-profit, government, and industry in Canada. The Canadian government has chosen "Innovation and Partnership" as one of the five themes around which to develop the national presentation in Johannesburg, 2002. Therefore, the conference is an excellent and timely opportunity to showcase Canada's achievements, and to encourage more partnerships leading up to Johannesburg 2002.

CIELAP is well placed as a key NGO player leading up to the World Summit next year. We hope to carry forward the momentum and enthusiasm from our meetings in Ottawa to a highly successful conference next April.

## **CIELAP** bolsters its biotech programs

CIELAP is preparing an interim report for CIDA on its three-year program on biotechnology and organic agriculture with Fundacion Ambio. Fundacion Ambio's model law on biosafety has been translated into English; Fundacion Ambio has developed a Citizens' Guide to Biotechnology in Spanish and is distributing this in Costa Rica. They have also developed a guidebook on organic in transition, also in Spanish. These Spanish documents will be on our website soon.

As well, CIELAP has prepared a brief report on regulations in Canada and our commitments to the Biosafety Protocol.

The labelling issue is still a matter of great debate in Canada. There is currently an industry led initiative on voluntary labelling and two bills have been introduced into the House of Commons on mandatory labelling. The two mandatory bills are Bill C-287, and Bill C-310, both are acts to amend the Food and Drugs Act. Bill C-287 was introduced by the Hon Charles Caccia (Davenport, Liberal) on February 28 2001. Charles Caccia moved on May 7 2001 that this bill be read for the second time and be referred to a committee. The bill has been debated on two occasions in the House of Commons. There may be another debate in the current session of Parliament. This bill may be referred to a committee for further study.

Bill C-310 was introduced into the House on March 28 by Ms Judy Wasylycia-Leis, Winnipeg, North Centre, NDP. The bill has not been debated in the House of Commons at this time. A motion could be made for a second reading in the current session of Parliament.

Now is the time to contact your Member of Parliament on this issue. Tell him or her what your views are on your right to know what is in your food. Should genetically modified foods be labelled as such?
